The information provided in this document is a summary of the key features and exclusions of the policy and does not form part of the contract between us. Complete pre-contract and contractual information about the product is provided in your policy wording.

### What is this type of insurance?

Travel Insurance provides cover for losses or events that may happen when you are on a trip.

An Annual Multi Trip Policy will provide cover for multiple trips taken within a year period. Each trip individually must not last longer than 32 days. A Single Trip Policy will provide cover for one trip.



### What is insured?

- ✓ **Who is covered**  
You and/or any named person.
- ✓ **Curtailment**  
We will pay you up to £7,500 per person for your share of:
  - unused travel and accommodation costs and
  - other pre-paid chargesthat you cannot recover from another company if you need to cancel or cut short a trip due to a number of listed reasons.
- ✓ **Medical emergency and repatriation expenses**  
If you are ill or injured we will pay up to £20,000,000 for hospital, ambulance, medical fees and to bring you home. A limit of £500 applies for emergency dental costs.
- ✓ **Baggage**  
We will pay up to £3,000 if your personal belongings are lost, damaged or stolen.  
The maximum we will pay for:
  - one item is £300,
  - all your valuable items is £300.
- ✓ **Personal Money**  
If your personal money is lost stolen or damaged we will pay up to:
  - £1,000 for cash,
  - for £500 cash if you are aged under 18, and
  - £300 for all other personal moneyIf your passport is lost, stolen or damaged and you need a replacement we will pay up to £500 for travel and accommodation.
- ✓ **Travel Delay**  
We will pay up to £600 if you arrive at least 12 hours late because your public transport is delayed.
- ✓ **Missed departure**  
If you miss your public transport to or from the UK because of a number of listed reasons we will pay up to £2,000 for your extra travel costs.

### What is not insured?

- ✗ Taking part in a sport or activity which is not listed in your policy wording, unless you have told us and we have agreed to cover it.
- ✗ If your physical ability and/or judgement has been affected because of alcohol abuse, or if you have taken drugs or used solvents.
- ✗ Any costs that you can get back from another company. Such as your airline, accommodation provider, ATOL bond or debit/credit card provider.
- ✗ The cost of Air Passenger Duty even if you cannot claim this back.
- ✗ Any claim for regional quarantine.
- ✗ Loss, theft or damage to valuables, cash, important documents or personal money which:
  - you have left unattended, or
  - that were in your luggage which was checked in with an airline.
- ✗ Any claim where you cannot travel or choose not to travel because the Foreign, Commonwealth & Development Office (or any other equivalent government body in another country) advises against travel due to a pandemic.
- ✗ Your inability to travel due to your failure to hold, obtain or produce a valid passport or any required visa in time for the booked trip.



### Are there any restrictions on cover?

- ! You may need to pay an excess of £50. This is the amount you pay when you make a claim.
- ! Children are only covered when travelling with the policyholder or a responsible adult.
- ! This policy is only available to people who:
  - live in the UK and
  - are registered with a GP in the UK
- ! You can only buy this insurance before you travel.
- ! If you have bought an annual multi trip policy:
  - You are only covered for trips which last up to 32 days or less
  - You are only covered to travel in the UK where you have at least 2 nights pre- booked accommodation or pre-booked transport planned



## Where am I covered?

- ✓ This product provides cover to travel anywhere within your selected area of travel as listed on your policy certificate.
- ✓ However you will not be covered for any claim caused by you choosing to travel to a country or region that the Foreign, Commonwealth & Development Office (FCDO) or other regulatory body has advised against travel to.



## What are my obligations?

- When you buy this policy you must tell us about the pre-existing medical conditions of anyone to be insured.
- You must take reasonable steps to protect yourself and your property.
- You must not travel against the advice of a medical practitioner or your public transport provider.
- You must not be planning to have medical treatment while you are on a trip.
- If you make a claim you must provide us with the evidence needed to substantiate your loss and you will need to pay for this.
- You should check that you do not have any other insurance policies that may cover the same events and costs as this policy.
- If you need to make a change to your policy during the year you will need to pay a £10 administration fee as well as any additional premium.



## When and how do I pay?

You will need to pay in full when you buy this insurance.



## When does the cover start and end?

### Single Trip policies

Cover in case you need to cancel your trip starts from the day you buy a policy. The remaining cover starts when you start your trip and ends when you return to your home.

### Annual Multi-trip policies

Cover will start on the day you choose when you buy this policy and will end a year later. There is no cover for any claim if the event happens before your policy starts.



## How do I cancel the contract?

### Single trip policies

If you cancel within 14 days of when you purchased the policy or the date you get the policy documents, we will give you a full refund as long as you have not travelled, no claim has been made and you do not intend to make a claim.

If you cancel more than 14 days after getting the documents, we will refund 65% of the premium paid, if you have not travelled, made a claim, or intend to make a claim.

### Annual multi trip policies

If you cancel within 14 days of when you purchased the policy, the date your policy renewed or the date you get the policy documents we will give you a full refund if you have not travelled, no claim has been made, and you do not intend to make a claim.

If you cancel after more than 14 days, we will refund a portion of the premium depending on how many complete months are left on your policy, as long as you are not on a trip at the time the policy is cancelled, have not made a claim, and do not intend to make a claim.
